

Early Years Pupil Premium Questionnaire

All early years' providers who deliver Government funded early education can claim the Early Years Pupil Premium (EYPP) for three and four-year-old children. If your child is eligible, the EYPP will provide your child's childcare provider with extra funding to enhance the opportunities, experiences and the support offered to your child. We need information about you and your child to provide the best education and support by making sure we receive all the government funding to which the childcare provider and your child are entitled.

What makes you eligible?

Children will be eligible if they are 3 or 4 years old, receiving Free Early Education Entitlement with any OFSTED registered childcare provider and their parent(s)/carer(s) are in receipt of one or more of the following benefits: **(please tick)**

How will you use my data?

Your provider and the LA is required to retain the information for 7 years for audit purposes in accordance with HMRC and the Department of Education. We may need to share your personal details with children's centres, schools, other services and childcare providers to further support your funding placement. Your information may be shared with other parts of government, other councils and our delivery partners to deliver you services or if required by law. This information may also be shared for monitoring, auditing and evaluation purposes. Under GDPR you have certain rights regarding access to the personal information that Enfield Council holds about you. You can request to see this personal information and our data protection policy by contacting The Early Years' Service. In the event of a data protection breach, ICO will be notified within 72 hours of the breach taking place.
