*** DIRECT DEBIT**

This is the easiest form of payment for many people. It will save you time, trouble and unnecessary costs. The payments will be automatically debited from the current account of your choice. You will be notified in advance of the payments and their due dates. You can cancel the arrangement at any time.

To pay by Direct Debit, simply fill in the Direct Debit Instruction overleaf and return to Enfield Council.

PLEASE NOTE: Payments will be taken monthly, unless you tick one of the boxes below.

ANNUAL/HALF YEARLY PAYMENTS

If you prefer to pay annually, please tick this box and send this form INTACT within 21 days. No agreement form is necessary.

ANNUALLY

If you prefer to pay half-yearly, a simple agreement form will need to be signed by you. Simply tick the box and send this form INTACT with your payment for half the amount due within 21 days. Once you have returned the signed agreement form you will be included in the half-yearly payment scheme and we will automatically deduct your payments until further notice.
